

GENERAL NOTES:


- The contractor shall confirm alignment of the DiamondWall with the grade shown on the contract plans.
- Contractor shall be responsible for determining the layout and location of the cross-sections in accordance with the owner's requirements and contract plans. At all transitions the taller wall section post size and spacing shall be maintained until the shorter section obtained.
- The contractor will provide quality control programs to ensure that the finished product meets the specifications
- Overall plumbness of wall 1"/10-ft of wall height.
- Overall plumbness of piling 1"/20' of exposed height.
- Sufficient drainage to be designed, installed, and connected to storm water management system by others.
- Contractor shall locate all underground utilities to avoid conflict prior to drilling foundations.
- Contractor shall complete subgrade requirements per site specific Geotechnical Report and contract plans provided by others prior to wall construction.
- Designed for a 3-sec gust wind speed equal to XX mph per ASCE 7-XX Risk Category I.
- Foundation design is in accordance to Geotechnical Report NO. XXX-XXXXX provided by XXX.
- All concrete shall have minimum compressive strength of f'c = 3000 PSI.
- Minimum foundation size and depth is in accordance with ASTM F567.
- All hardware shall be Galvanized Steel.
- All pipe shall be ASTM F 1083 Schedule 40, Grade XX ksi and hot-dipped galvanized.
- SE.DWP panel color shall be MONSTER GREEN / STADIUM BLUE / ALL-STAR GRAY.
- 16. Strut Channel Waler shall be P1000T with the following properties:
- 16.1. Guage = 12 (Minimum)
- 16.2. Ry = 33KSI
- 16.3. E = 29,000 ksi
- 16.4. Area = 0.55 in^2
- 16.4.1. $lx = 0.185 in^4$

- 16.4.4. Sy = 0.290 in^3
